I am writing you today as an experienced registered nurse and occupational health and safety specialist. Every Occupational Health Nurse requires the right support systems to practice. So on behalf of all occupational health nurses, I asked RNAO to detail membership benefits.

Please read how RNAO and OHNIG membership can support your practice and protect you as a professional. Click on the blue color links to view a host of benefits ranging from specialty certification, legal protection, continuous learning and professional development, networking opportunities, financial savings and a "voice" to speak out for improvements in health care system and nursing policy.

Currently 35,000 nurses and nursing students have chosen to get involved with RNAO to have a proactive association working for them that provides many worthwhile membership benefits.

SPECIALTY CERTIFICATION

RNAO members are part of the Canadian Nurses Association, and are eligible to save \$233.91 on initial examination fee for <u>certification in Occupational Health</u>. Canadian Occupation Health Nurse Certification earns a registered nurse the COHN(C) designation. RNAO is also currently negotiating with the <u>Canadian Occupational</u> Health Nurses Association to provide group rates for this national body for all our members.

LEGAL PROTECTIONS

As a benefit of RNAO membership, you are eligible for professional liability protection from the <u>CANADIAN NURSES PROTECTIVE SOCIETY (CNPS)</u>. By adding \$64.57 to your membership to enroll in the <u>LEGAL ASSISTANCE PROGRAM (LAP)</u>, you are eligible for legal assistance with employment related matters including wrongful dismissals and complaints to CNO; making your protection more comprehensive.

RNAO provides benefits that are designed by nurses for nurses. Depending on your needs, your membership in RNAO, LAP and OHNIG can cost under \$350/year, which is much less than what other associations charge.

CONTINUOUS LEARNING & PROFESSIONAL DEVELOPMENT
