### POLICY/POLITICAL ACTIVITY

#### **Expert Panel Recommendations to MOL on Health and Safety Mandatory Training in the Workplace.**


The Occupational Health Nurse Interest Group posted on their web site the just released report December 2010. The public consultations revealed that there is a lack of foundational, basic information among workers about the existence of “the green book”: that Ontario has an Occupational Health and Safety Act: and those owners, employers, supervisors and workers all have rights and responsibilities. In the view of the Panel, everyone needs to be aware of these rights and responsibilities, regardless of their role within the workplace.

It is important that everyone read the Expert Panel recommendations on **Occupational Health and Safety - Mandatory Health and Safety Training in the Workplace**. Please note these are only recommendations at this point. It replaces nothing right now, therefore there are no penalties attached. However anyone who works in a workplace has a responsibility to know their responsibilities.

#### **College of Nurses of Ontario CNO Proposed New Regulations, about to be Implemented**

OHNIG brought to the attention of their members the proposed new regulations about to be implemented by the College of Nurses of Ontario CNO. The proposed amendment will require all Registered Nurses to have mandatory professional liability protection. The members were asked to read the proposal and provide their input by the deadline date. As of December 14, 2010 a decision has not yet been made.
